

The Board of Health is pleased to present the Central Connecticut Health District's (CCHD) adopted budget for Fiscal Year 2010-2011. This budget shows the membership fee remaining the same at \$4.06 per capita for the sixth year in a row.

We serve as the local health department for a population of 94,634 people in the towns of Berlin, Newington, Rocky Hill and Wethersfield, CT. Our central office is in the Wethersfield Town Hall, with satellite offices for the Sanitarians in each of the other three town halls. Our Community Health Coordinator is located in the Newington Senior and Disabled Center.

Highlights of some of our recent accomplishments and future plans include:

- We provided the local public health response to the H1N1 Swine Flu outbreak. During the spring of 2009 we monitored the outbreak and provided guidance to schools, residents and town leaders. We became a vaccine provider and vaccinated just over 6,000 people.
- We hired a part-time salon inspector to implement our new salon regulations. We inspected and licensed over 160 establishments.
- We obtained grant funding to support a variety of programs and services such as a dental cleaning for seniors, a "Putting on Airs" asthma home visitation program, a Healthy Dining Program designed to get restaurants to offer healthy meal choices, child safety seat inspections and a teen seatbelt use awareness program.
- We updated our Community Health Report Card for the eighth year in a row showing the latest demographics and reportable disease information.
- We provided 3,192 influenza immunizations and 129 pneumonia immunizations.

We are fortunate to have a considerable number of volunteers who donate their time and expertise to support our programs and services. Many of the programs and services that we offer, in particular our annual influenza immunization clinics, would not be possible without them. The Board of Health and staff would like to thank all of our volunteers for their many hours of support.
