- **2. Director Health and Staff** Brown highlighted the following:
  - Plans for drive through flu clinics are finalizing. Thank you to Sartucci and Doot and all the volunteers for their help at the flu clinics.
  - Flu clinics have been very successful; 819 flu shots in Wethersfield and 490 in Berlin.
  - Staff and volunteers are amazing in helping to carry this off.
  - Thanks to Annie for stepping up at clinics when I am called away and enduring staff.
  - Environmental Health staff member Barbara Gigliotti has done an excellent job walking business through zoom meeting with regulated agencies in Wethersfield.
  - Cheryl Kissinger has done a great job in getting grants closed out and getting ready for the audit.
  - Newington Chamber of Commerce will be presenting a "best of" award to the Health District for doing an outstanding job supporting local businesses during this pandemic.
  - Superintendent of Rocky Hill schools want to recognize us for all the work we have done during COVID.

#### H. NEW BUSINESS

**1. CCHD Sanitary Code Review Presentation** – Brown gave a presentation of the Sanitary Code and answered and clarified questions.

**MOTION** by Sartucci to approve the recommendation of the Governance Committee to accept the proposed sanitary code and to move forward for review and public hearing process prior to adoption. **Motion carried unanimously.** 

## 2. Public Health Thank You Day -

**MOTION** by Zartarian, seconded by Paonessa to adopt a plan for recognition of staff through a public health thank you day on November 23, 2020. **Motion carried unanimously.** 

## 3. Co-Vid and Influenza Updates -

- Staff have been keeping up with information from CDC and CT Department of Public Health since December. Currently 1564 confirmed cases in the district; 498 in Rocky Hill, 506 in Newington, 231 in Berlin and 329 in Wethersfield. 174 deaths in the district; 94 in Rocky Hill, 52 in Newington, 17 in Berlin and 11 in Wethersfield.
- All towns have opened their schools. Each town has had many inschool issues to deal with that required assistance from the Health District.

- Volunteers are doing an excellent job on our contact tracing. Almost 832 cases and contacts have been tracked using the state system since May 20<sup>th</sup>.
- Executive orders are still an issue. Executive Order 9G is an issue because of inconsistent application of policy.
