• Committee discussed issues related to the new fiscal year that would affect budget considerations. These issues include negotiations between the collective bargaining unit and the agency, increases in overhead expenses like rent and utilities, possibilities of grant funding being threatened from competition, expansion of staffed positions due to COVID-19 and ongoing support. Committee members felt that there exists some uncertainty in expense items like health insurance and contractual support due to inflationary pressures in the short term. Additionally, items purchased to outfit office space three years ago may need to be replaced and funding for that purpose should be considered soon.
