# 2. Community Health Assessment (CHA) update

- Brown reported that contractor had completed data collection project utilizing Farmington Valley Health District framework. Additional data collection from MAVEN Disease surveillance system will be conducted and the data will be reviewed for gaps.
- Checko reported that DataHaven had issued town level Health Equity reports for download. Brown has downloaded all town reports for district and these will be reviewed for relevance to CHA.

#### VI. NEW BUSINESS.

# 1. Public Health Accreditation Update

• Sartucci sat in on conference call at NALBOH about PHAB being revised and that new standards may be available by the end of the year. This is the 3rd set of standards and it may offer easier opportunities to be accredited but still challenging. She also reported that the 10 Essential Services of Public Health have been revised and Governance and Administration are being integrated into 10 standards instead of standing alone. She stated small LHDs serve most of the country and larger agencies are being accredited currently but many smaller LHDs are not, especially with COVID. An effort to put in place "pathways to accreditation" for smaller LHDs is being developed.
